## LPC Lot Line Survey

Nate Yager of Latitudes Land Surveying, Inc. has started the process of gathering data from the Town of Ferrisburgh and LPC to begin inputting information for all LPC and lots. In working with Latitudes, the Lot Line Committee has reviewed all lease lot descriptions and reformatted the descriptions as needed to improve the ease of use. The Lot Line Committee has also reviewed all known files specific to the location of wastewater: the location of holding tanks, septic tanks, leach fields, alternative systems, etc.



As the process moves forward, members of the Lot Line Committee may contact stockholders to clarify information specific to lot descriptions and wastewater fields should there be questions. Yes, there are still a lot of descriptions referring to an old cedar tree or a mark on a rock near the large oak, or the field is located in a northerly direction from the camp.

## Emerald Ash Borer Phase 3 Update

Teacher's Tree Service completed Phase 3 of the EAB removal in January. The focus of the removal was Bay Road, East Road, and Kirsch Lane. A raw cord of ash was delivered to 9 stockholders per their request. LPC did not sell any sawlogs due to the size and quality of the logs. Ash trees less than 4–5 inches in diameter at chest height was not removed in hopes that they will avoid the ash borer. The state map indicating the location of the EAB in the Vermont towns and across the state doesn't appear to have been updated since the fall. You may link to the following site for updates:

### Notes from your treasurer:

This past season was a tough one financially. The board has struggled to keep within the budget approved back in August 2021 for the 2022-2023 season. As is true for all of us personally, the cost of everything has greatly increased for Long Point. Thanks to many volunteers, we have been able to keep Long Point functioning. Due to inflation, postponed work on the farmhouse because of the pandemic, and increases in contracted labor, I feel I should let you know ahead of time that it will be necessary to increase assessments going forward.

The water system expenditures this past season were twice as much as in past years due to many leaks needing to be repaired and other system failures. As a result, the water reserves were totally depleted. Thus, the water system users will see a sizable increase in the water assessment budget for 2024-2025 which will be voted on in August 2023.

Our reserves are an important financial life support we need to maintain and no doubt increase. This self-insurance is similar to what HOAs (homeowner associations) charge and set aside for upkeep, major repairs, and emergencies. We have been charging ourselves bargain prices for the services provided. To be realistic, we need to increase our reserves as a cushion against inflation and unforeseen repairs and save for anticipated replacements.
